1. Absentee bids are treated in the same manner as bids accepted from the floor: i.e. title passes to the successful bidder at the fall of the hammer, with no returns accepted.
2. The floor has precedence in the event of a tie bid.
3. Absentee bids are confidential and are bid competitively against the floor. An absentee bid cannot open the bidding.
4. We will attempt to execute your bid but we CANNOT GUARANTEE that we will not miss and absentee or telephone bid.
5. Bids will not be accepted unless information is complete and legible.
6. A Buyer's premium of 19.50% will be added to the hammer price of each lot.
7. All payment, shipping or pickup arrangements MUST be made within seven days of the auction date. There will be a storage fee of \$10 per lot per week starting after the seventh day.
8. A Credit Card # is **REQUIRED** to place telephone and absentee bids. No exceptions! Your account will be authorized for \$1000.00 or we can require a specified retainer amount of 10% of the low estimate on lots valued over \$20,000. If we cannot authorize your account your bids will not be processed.
9. International bidders must also include a copy of their passport and bank details.
